**RESOLVE:**

Art. 4º Designar para integrar a Comissão Permanente de Tecnologia da Informação e Infraestrutura, sob a presidência do primeiro, os Conselheiros Silvio Luis Ferreira da Rocha, Gilberto Valente Martins e Wellington Cabral Saraiva.

Art. 5º Alterar o nome da Comissão Permanente de Acompanhamento Legislativo para Comissão Permanente de Articulação Federativa e Parlamentar, designando para integrá-la, sob a presidência do primeiro, os Conselheiros Bruno Dantas, Carlos Alberto Reis de Paula, José Roberto Neves Amorim e Jorge Hélio Chaves de Oliveira.
